Taken the Membership of the Institute of Agriculture Environment Forestry (IAEF) Lucknow UP-India shall be open to individuals & corporate, educational institute, NGOs, Development Organization, Trust and other societies from all National/International shall consist of the following categories of members with qualifying criteria as indicated against each. Membership can be obtained by filling a membership form and sending it to **rkdoharey@iaef.org.in** along with membership fee.

- (I) Annual Membership (Academicians, faculty etc.) This membership shall be offered to the individuals interested in promotion of Agriculture, Extension and its allied sciences. There shall be an annual membership fee of ₹ 2000/- for one year for individuals in citizen of India and other than India US \$ 24.10 for one year.
- (II) Life Membership: There shall be life time membership for ₹ 4000/ in one time for individuals from citizen of India and other countries US \$ 48.10 for individuals.
- (III) International Annual Membership: US \$ 120.10/ for one year to the individuals.
- (IV) International Life Membership: US \$ 240.10/ for payment of one time
- (V) Student's Annual Membership: Student's annual membership fee of ₹ 1000/ (for one year) for citizen of India and other than India US \$ 12.10 for individuals.
- (VI) Organizational Membership (Corporate, Educational Institute, Societies, NGOs, Trust etc.) Indian Institution/organization, society, NGOs, etc. making a membership for payment of ₹ 20,000/- for one time and other than India US \$ 480.20 for pay one time substantial (as may be increase prescribed by the Executive Board from time to time).
- **(VII) Subscriptions:** Any corporate body/Institution/Library/Association or persons can subscribe Indian Journal of Agriculture Research & Environment (**IJARE**) and Journal of Extension Education & Applied Sciences (**JEEAS**) by making an annual payment of ₹ 20,000/ for India and other tan India US \$ 480.20 for annual subscription for each journal.

(VIII) Paper Processing Charge: ₹ 250/Per page/per paper in each journal.
